### **Purpose of collecting personal information**

2. to inform users of various events that the website syndimiourgia.gr participates in or organizes

In order to serve the above purposes, we may contact you by email, by telephone, or via SMS as long as you have provided us with such information.

### **How your Personal Data is collected;**

Providing all personal information is voluntary.

We collect personally identifiable information as a result of your choice, either directly from you or from any devices (including mobile devices) you use when you:

- provide us with information about you in the site's communication forms
- submit a comment or query via the syndimiourgia.gr website

### **The kind of Personal Information we collect**

2. IP address

### **What are the user's rights on his / her personal data?**

- You have the right **to know** which personal information we hold for you and to request **the portability** of your information. We will provide you with a copy of your personal information in a structured, widely used and readable form at your request.
- If your personal information is incorrect or incomplete, you have the right **to request** modification(s).
- You may request **to delete or restrict** the way we use your personal information as defined by applicable law.
- You have the right to request **the restriction of the processing** of your personal data and **to oppose to the processing** of your personal data.
- At your request, **we will cancel your subscription to our newsletter** and we will **remove your personal information** as soon as possible in accordance with applicable national laws.

The period of completion of each request is **30 days** and there may be an extension of this period, after you have been informed

### **How long is your personal data maintained?**

We keep your personal information for as long as you wish. Upon request, we will safely delete your personal data from our database, in accordance with the data retention and deletions policies.

### **How is your personal data protected?**

We protect your personal information by using security measures to reduce the risk of loss, misuse, unauthorized access, disclosure and modification of your personal information.

### **Partners of the website syndimiourgia.gr**

The website syndimiourgia.gr may disclose certain personal data to third parties to facilitate the activities of sending the newsletter and communicating with you. Our affiliates are covered by the confidentiality obligation and the GDPR Regulation.
